1. Call to Order and Roll Call

President Smith called the regular meeting to order at 6:00 p.m. Board Secretary Lisa Johnson called the roll. Seven members were in attendance.

2. Fiduciary/Budget Presentation

Business Manager Johnson discussed February financials and answered questions from the board members. Business Manager Johnson also spoke to the board of the upcoming budget presentation at future board meeting on April 9th. 4. Public Hearing: Early Start Calendar

High School Principal Kevin Seney discussed the 14-15 School Year calendar and the early start waiver. He also confirmed that this early start would still be after the Iowa State Fair concludes. Board member Wilhelm voiced concerns of days of attendance for students after the Memorial Day holiday. She would also like to voice the preference for year-round school. President Smith went over the states requirement of the district's waiver approval needed to start school before the September 1st date.

6. Communication and Reports

A. Board

Board member Fisher mentioned the Academic Committee working on the goals and discussion of the "clustering" concept. The Early Literacy Program will be a topic of discussion in the future by board member Moisan on behalf of the Academic Committee.

B. Superintendent

The demolition on the RC property is approximately one-third complete, and on the south side the building is down. Superintendent Abrahamson shared the calendar that outlines the schedule for the continued demolition on the property.

In reference to budget it was mentioned that despite revenue estimates continuing to rise, the senate passed at 6%. Although the house is still holding out on approval measures. The timeliness of funding is important to help with the prediction and forecasts of future budgets.

C. Principals

Middle School Principal Sara Hegg-Dunne gave the board an overview of the success of various middle school programs throughout this school year.

Fifth grade teacher Lisa Cirks presented the blog website that her students are using to post their writings. Students can read each others in their class, other middle school classes, and even other students in school districts they are partnering with. Board member Wilhelm inquired if there is the ability to carry forward each students work into their future years? Mrs. Cirks said that this is not currently an option used, but they are looking into the capabilities for the future.

Sixth grade teachers Tammy Strawser and Rebecca Goltz are teaching students how to find reliable data information and sources online. Their students are also creating videos of past news history. Mrs. Strawser used a virtual room makeover project to teach shapes and budgets when designing a room makeover. Also, using i-movies and other technologies to get students interested in their curriculum by using technology.

Seventh grade students are using videos to help create stories. A student presented the board an example of her work, and explained how she went through the creative process.

Eighth grade students were exploring their career opportunities through technology. They used online quizzes to help narrow their focus and assist with selection of classes in their future high school years. A middle school student gave an overview of her and her families experience of how this help planned for her potential future career choices.

Middle School teachers Janelle Pirkl and Josh Ellis presented to the board their use of the Canvas and EdModo programs. Examples and comparisons were given by each of them to show how they can track assignments given to students. Also, how they can monitor the student's submitted work and return to them with comments.

Principal Hegg-Dunne told the board of the setting up student help desks in the media center this spring on a trial basis.
