IF THE EMPLOYER CUSTOMARILY DISTRIBUTES INFORMATION TO EMPLOYEES BY ADDITIONAL MEANS, SUCH AS BY E-MAIL OR HARD COPY, THE EMPLOYER SHALL PROMPTLY DISTRIBUTE THIS NOTICE TO THE AFFECTED EMPLOYEES THROUGH THOSE MEANS AS WELL.

**NOTICE TO EMPLOYEES
FROM THE
PUBLIC EMPLOYMENT RELATIONS BOARD**

Pursuant to the Public Employment Relations Act, Iowa Code chapter 20, the Public Employment Relations Board (PERB) certified Physical Plant Employees (Blue Collar) as the exclusive bargaining representative for the bargaining unit of Grinnell-Newburg Community School District employees described at the end of this document.

Iowa Code section 20.15(2) requires PERB to conduct a retention and recertification election. In this election PERB will ask the employees in the bargaining unit whether you wish to retain and recertify Physical Plant Employees (Blue Collar) as your exclusive bargaining representative for purposes of collective bargaining.

Iowa Code section 20.6(7) and PERB subrules 621—15.1(1) and 15.5(5) require that Physical Plant Employees (Blue Collar) pay an election fee. This fee must be paid by Monday, September 14, 2020.

If Physical Plant Employees (Blue Collar) fails to pay the required election fee, PERB will revoke its certification. If PERB revokes the certification of Physical Plant Employees (Blue Collar) your collective bargaining agreement may become void and the terms of the agreement may become unenforceable.

IF AN ELECTION IS HELD, your employer shall post and distribute, in mid-September, a Notice of Election giving details on how and when to vote. The election period will be from 7:00 a.m. on Tuesday, October 13, 2020 to 9:00 a.m. on Tuesday, October 27, 2020. The election will be conducted by the Public Employment Relations Board and your right to a secret ballot and a free choice will be protected.

BARGAINING UNIT OF EMPLOYEES OF Grinnell-Newburg Community School District

**The unit description below is subject to the mutual agreement between the parties concerning who is eligible to vote in the upcoming recertification election.

INCLUDED: All housekeepers, custodians, boiler operators, maintenance personnel, head custodians and foremen.

EXCLUDED: Physical plant supervisor, all professional employees, bus drivers, cooks, all other employees, and all those excluded by Section 4 of the Act.
